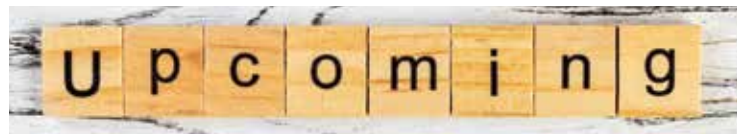

Download our SHAZAM BOLT\$ app! This easy-to-use app allows our cardholders to set their own transaction alerts and receive notification of account

activity. You will also receive notifications if there is potential fraud. They will ask you to call SHAZAM to verify the account activity or report fraud. If there has been fraud on your account or if your card is lost or stolen, you can use the Transaction Control setting to temporarily lock your card.
